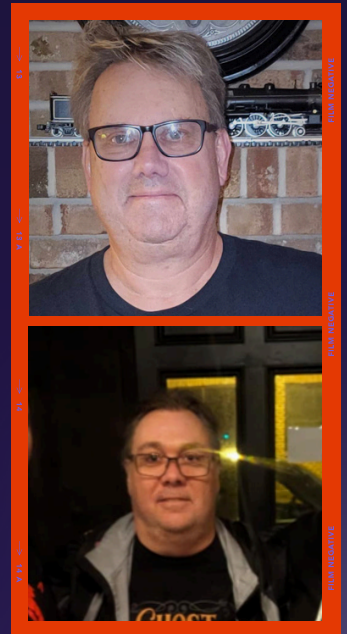
OUR EVIDENCE REVIEW TECHS

The Evidence Review Team (ERT) is a specialized section of The Haunted Mafia, tasked with overseeing investigation reviews.

This dedicated team is committed to gathering evidence related to paranormal activities while also viewing questionable findings as valuable learning opportunities. By leveraging each member's strengths and providing mentorship, we foster a vibrant environment for our reviewers. Typically, our review process for investigation evidence spans about two weeks, during which we analyze audio, video, trail camera footage, and various photographs. A key part of our approach involves breaking down evidence into segments of less than one minute to ensure clear context.

Currently, our team consists of five devoted members who invest countless hours in the quest for solid evidence. Leading the team is Allen Rex, our Chief Operations Officer and Co-Founder. Seth and Bree are our most seasoned members, adept at reviewing any type of file presented. Seth plays a crucial role in editing evidence clips to meet the required length and assists newer members with training and logistics. David Wigg (DW) has quickly made a name for himself with his enthusiasm for reviewing photos and is eager to gain more experience in audio and video capture. Dave Rowland brings invaluable expertise in video editing, consistently helping to upload clips into our review area. Additionally, Dave (DR) acts as our historian, compiling all relevant information about the locations we investigate.

INVESTIGATOR SPOTLIGHT: DAVE ROWLAND

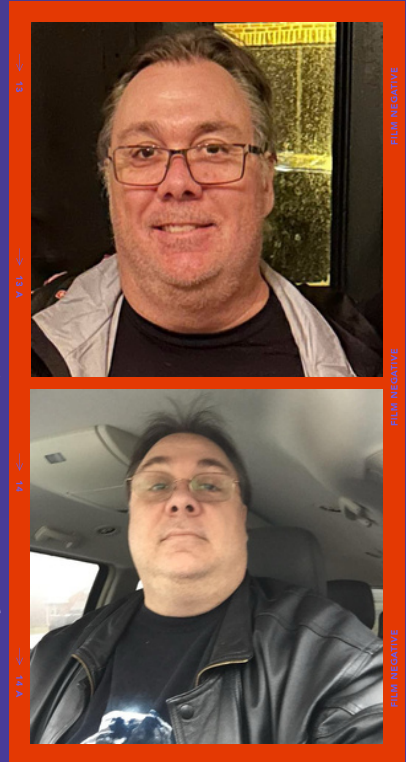
Twenty-eight years ago, when Dave first entered the realm of the paranormal, interest in the supernatural was quite limited. His journey began when he stumbled upon a video and received an invitation from the International Ghost Hunter Society to attend a conference in Gettysburg, sparking his curiosity in the field.

At the conference, Dave had a unique opportunity to visit locations in Gettysburg that were generally off-limits to the public. He became part of a local ghost group formed by residents, where he forged a strong friendship with another investigator. This relationship blossomed into a significant partnership, resulting in the creation of Pennsylvania Paranormal Investigations. During that time, only two paranormal groups were operating in the area, allowing for more exclusive and less competitive investigation opportunities.

However, after the devastating loss of Dave's best friend in 2009, the original chemistry of the group faded, leading to its eventual disbandment. In the following years, Dave continued to explore paranormal sites and even established a new group. Unfortunately, this new initiative struggled with a lack of long-term commitment from its members, causing interest to decline.

During this period, Dave came across an advertisement for a meet-and-greet event hosted by a group from Palmerton. Intrigued, especially since Palmerton was the hometown of his mother and grandparents, he decided to attend, eager to learn what insights a small-town group could provide. To his delight, the group was well-organized and filled with a warm, enthusiastic team. After participating in several investigations, he developed a close friendship with two members, Allen and Laurissa, who were highly respected within the group.

By the end of the year, Allen extended an invitation for Dave to officially join the group, which he gladly accepted, feeling that they had not only found a new team but a new family. Today, Dave values the respect and trust he has earned, often being approached for his vast knowledge and experience acquired over his years in paranormal investigations.

A TV SERIES AND A BOOK ON THE HORIZON!



In 2023, our CEO, Laurissa, teamed up with Angie Moyer, the Owner of Waldorf Estate of Fear and our partner for the "Hell House" paranormal tours, along with paranormal investigator Sarah Grim, to develop the TV series "24 Hours in Hell: A Paranormal Journey Through Hell House (The Waldorf Estate of Fear)." This series is based on three years of research by The Haunted Mafia paranormal team, delving into the phenomena associated with the filming of the Hell House, LLC, movie franchise at The Waldorf, as well as the haunted attraction itself, which until 2024 lacked any significant documented historical records. The show's aim is to offer investigators from diverse and unique backgrounds an immersive 24-hour experience of the paranormal activities at this location.

Thanks to Laurissa and Angie's extensive networking in the horror and paranormal industries, prominent figures like Santiago Cirilo (The Walking Dead), David Childers (Travel Channel/Discovery Channel), and select members of The Haunted Mafia team participated in a ten-month filming schedule. During this time, guest investigators were recruited from diverse backgrounds, including social media reality stars and individuals with ancestral roots to the land that date back to the establishment of the hotel and township.

The filming process yielded remarkable findings, including the discovery of previously unknown historical documents related to the location. The show, along with the research conducted by The Haunted Mafia team and the evidence collected before and during filming, inspired Laurissa to write a book titled "The Waldorf Effect: A Paranormal Research Theory."

In July 2024, Laurissa embarked on a nationwide tour to promote the show, the book, and her new theory, which suggests that the hauntings at this location generate an effect unlike any seen elsewhere. While exclusive management services are no longer available, Third Eye continues to offer media kits and additional services, including Talent Scout Services. Clients participating in this service are not bound by contracts but instead join a secondary roster. If the initial five clients aren't suitable for an event after being recommended to an organizer, Third Eye will provide a referral for a nominal fee. To access this service, clients must first purchase a media kit through Third Eye Event Productions. Media kits can be viewed on the website, and requests can be submitted via the provided link.

The referral fee is modest and is calculated as a percentage of your booking fee. If you do not receive payment for an appearance, there is no fee. Additionally, appearances booked with "guarantees" require a flat fee. Clients who book with an organizer for a return event after their initial appearance will not be required to pay the fee again unless they did not pay it during their first appearance.
